

Terms and Conditions

1. Information on How to Enter and Prizes form part of these Conditions of Entry.
2. The promotion period begins at 1.00 A.M on May 1st, 2017 and ends at 11.59 pm (AEST) on September, 30th, 2017.

 - Make a qualifying purchase
